International coordinated audits in the field of waste management

These audits are instrumental in :



determine the best practices



compliance with international standards and regulations



identified deficiencies in national legislation



identification of more effective waste management systems



Focus on specific international coordinated audits



Transboundary movements of wastes in the light of the Basel Convention provisions

The objective of the audit was to determine the facts and to assess the scope of compliance with the **Drovisions** of the "Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and their Disposal" between Ukraine, the Slovak Republic and the Republic of Poland as well as to assess the state of implementation of recommendations



BASEL CONVENTION

As a result of the audit, participants recommended

improvements to the system for controlling transboundary waste transport between Ukraine, Slovakia, and Poland.

Specifically, they suggested making necessary amendments to national legislation



Our monitoring has shown

Several recommendations were taken into account in Ukraine when the Law of Ukraine "On Waste Management" was adopted in 2022

Amendments to the Law of Ukraine "On Licensing Types of Economic Activity"

Determination of the List of Properties Making Waste Hazardous

Amendments to the Law of Ukraine "On Environmental Impact Assessment"

Establishment of Liability for Violations in Waste Management

International Audit on Waste Management and Utilization

The audit was aimed at assessment of the status and effectiveness of waste management systems in the countries of audit participants



It was recommended by the participants

The Governments should to intensify efforts for transition from a linear economy to a circular, based on maximum waste recycling, and creation of an integrated waste management system according to the existing waste management hierarchy in the EU





The Law of Ukraine "On Waste Management"



Iaunches Waste management reform in Ukraine and implements EU standards to Ukrainian legislation



Regulation of relations concerning a waste management, including collection, transportation, processing, utilization, and disposal of waste



Establishment of legal, organizational, and economic principles for activities to prevent waste generation, reduce waste, reuse, recycling, and disposal



With the launch of waste management reforms, the situation in our country was expected to change dramatically



Russia's military aggression against Ukraine has significantly complicated the situation


Demolition waste carries catastrophic consequences for the environment

More than 950,000 tons of demolition waste have already accumulated in Ukraine, and this figure is increasing daily

It contains many hazardous substances, including a significant amount of asbestos-containing materials

Unexploded ordnance and debris from it, burned vehicles and military equipment, used disposable NLAW systems, batteries, etc.

Military actions have led to a massive amount of demolition waste containing hazardous substances

Many countries focus on the reuse and recycling of construction waste.

88% of construction waste was recycled in the European Union in 2018
